## **Dog Training:**

Training is a lifelong commitment. Trainer and Karisha Anderson will make every reasonable effort to teach Client and Dog to perform the skills and address behavioral issues as discussed. Trainer and Karisha Anderson do not make any guarantee of Dog's future performance or behavior as a result of providing training. It is the Client's duty to practice and reinforce on a daily basis at home the commands taught. Client understands without practicing and reinforcing behaviors, they will naturally become less reliable over time.

**Fees:** Training camp is \$95 per day per dog and takes place on the Trainer and Karisha Anderson's home property. There will be a \$200 non-refundable fee to hold the startdate for training. This fee will be applied to the overall training costs. You may change your drop off date one time without incurring additional charges. One-half of the total training cost must be paid on the day of drop off, with the remaining balance, including any additional charges to be paid on the day of pick up. The cost of training does not include food, vet bills, grooming or training equipment. If needed these items will appear on your final invoice.

Training camp fees include all daily training and two private lessons. One private lesson when you pick your dog up and one to be scheduled within two weeks of the conclusion of the training program, either on the Trainer and Karisha Anderson's property or another specified location. Plan on spending at least two hours with the Trainer and Karisha Anderson for each follow up. You will also receive a packet of training information and exercises to help you complete your training once you get home.

The undersigned is voluntarily engaged in training/boarding as an activity with the knowledge of the risks of injury, death and property damage that may result from participating in training/boarding.

**RELEASE OF LIABILITY:** Trainer and Karisha Anderson agree to exercise due and reasonable care of Dog. However, Trainer and Karisha Anderson are not liable for loss or damage from disease, death, escape, theft, fire and injury to person(s), other animal(s) or property by Dog during or after the term of this Agreement. Client agrees to pay resulting losses and damages suffered or incurred and to defend and indemnify Trainer and Karisha Anderson and Canine Country Club of the South, its employees, interns, volunteers and agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. This agreement supersedes all prior discussions, representations, warranties and agreements of the parties and expresses the entire agreement between Client and Trainer and Karisha Anderson regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or understandings have been made with regard to Dog or anything else. Client acknowledges that Trainer and Karisha Anderson has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavior problems, or that the results of training will last for any particular amount of time.

The undersigned releases Trainer and Karisha Anderson and Canine Country Club of the South, its owners, officers, directors, employees or agents from all liability to the undersigned and the undersigned's representatives, guardians, successors, assigns, heirs, children and next of kin for all liability, claims, damage or demands for personal injury, death or property damage, to the undersigned or to the undersigned's dog or dogs, arising from or related to this agreement or to the participation in training/boarding, whether the injury, death or property damage occurs in the undersigned's personal home or elsewhere. The undersigned bears the sole responsibility for any loss.

This agreement may be amended only by a written instrument signed by both Client and Karisha Anderson.

**Arbitration:**
