Dog Training:

Training is a lifelong commitment. Owner, Karisha Anderson, will make every reasonable effort to teach Client and Dog to perform the skills and address behavioral issues as discussed. Karisha Anderson does not make any guarantee of Dog's future performance or behavior as a result of providing training. It is the Client's duty to practice and reinforce on a daily basis at home the commands taught. Client understands without practice and reinforcement of commands, they will naturally become less reliable over time. One-half of the total training cost must be paid to secure your drop-off date, with the remaining balance, including any additional charges to be paid on the day of pick up. The cost of training does not include food, vet bills, grooming or training equipment. If needed these items will appear on your final invoice.

Club Membership:

Membership is required for all dogs participating in our boarding, training, or daycare programs. The annual membership fee is \$50 per year. Your membership with us includes several premium features designed to make caring for your pet more convenient and stress-free:

Flexible Hours:

- Open for drop-off and pick-up Monday through Saturday, 8am-5pm
- No specific drop-off or pick-up windows required (unlike most facilities with narrow time slots)
- Staff lunch hour from 12-1pm (no drop-offs or pick-ups during this time)

Consistent Pricing:

- No holiday rate increases
- No change fees for adjusting your reservation
- No cancellation fees

Professional Support:

- Access to our professional trainers for dog-related questions Monday - Saturday via text or phone
- Refresher training for your dog with each boarding stay

Emergency Services:

- After-hours **emergency** drop-off available for boarding clients at no additional fee
- 24/7 staffed facility with personnel on property 365 days a year (we're never a "turn-key" operation)

Assumption of Risk and Waiver of Liability:

ASSUMPTION OF RISK: The undersigned is aware of the inherent risks of injury, death and property damage to the undersigned or to his or her dog(s) that are involved in the activity of training/boarding, including without limitation risks due to dog bite or infectious disease. The undersigned is aware of the risks of injury, death and property damage that may result from, among other causes, the active or passive negligence of Canine Country Club of the South, owners, officers, directors, employees or agents. The undersigned is voluntarily engaged in training/boarding as an activity with the knowledge of the risks of injury, death and property damage that may result from participating in training/boarding.

RELEASE OF LIABILITY: Trainer and Karisha Anderson agree to exercise due and reasonable care of Dog. However, Trainer and Karisha Anderson are not liable for loss or damage from disease, death, escape, theft, fire and injury to person(s), other animal(s) or property by Dog during or after the term of this Agreement. Client agrees to pay resulting losses and damages suffered or incurred and to defend and indemnify Trainer and Karisha Anderson and Canine Country Club of the South, its employees, interns, volunteers and agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. This agreement supersedes all prior discussions, representations, warranties and agreements of the parties and expresses the entire agreement between Client and Trainer and Karisha Anderson regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or understandings have been made with regard to Dog or anything else. Client acknowledges that Trainer and Karisha Anderson has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavior problems, or that the results of training will last for any particular amount of time.

The undersigned releases Trainer and Karisha Anderson and Canine Country Club of the South, its owners, officers, directors, employees or agents from all liability to the undersigned and the undersigned's representatives, guardians, successors, assigns, heirs, children and next of kin for all liability, claims, damage or demands for personal injury, death or property damage, to the undersigned or to the undersigned's dog or dogs, arising from or related to this agreement or to the participation in training/boarding, whether the injury, death or property damage occurs in the undersigned's personal home or elsewhere. The undersigned bears the sole responsibility for any loss.

This agreement may be amended only by a written instrument signed by both Client and Karisha Anderson.

Arbitration:

IN the event a dispute shall arise between the two parties to this Agreement, it is hereby agreed that the dispute shall be referred to the American Arbitration Association

("AAA"). The site of the hearing shall be in the city of Atlanta, Georgia, for arbitration in accordance with the AAA Rules and Procedures. The arbitrator's decision shall be final and legally binding and judgment may be entered thereon. Each party will bear its own costs and expenses and attorney's fees.

KNOWING and VOLUNTARY EXECUTION: The undersigned acknowledges that he or she has carefully read this agreement, understands its contents, understands that he or she will be responsible for all costs incurred concerning my pet during the training/boarding program and release from liability Canine Country Club of the South and Trainer and Karisha Anderson. Furthermore, the undersigned has disclosed any aggressive tendencies their dog(s) may have.
